Barking Heaven Boarding Agreement

Barking Heaven Boarding Kennel provides exceptional loving care and attention to the boarded animals. The kennel while taking all reasonable care will not be held liable for any loss or damage including but not limited to fire, theft, disease, death, escape or injury for pets in their care.

All persons entering the property do so at their own risk; and the kennel will not be held liable for injuries, or harm to persons while on our premises.

To maintain the safety and happiness of our boarders, pets that exhibit aggressive behavior while boarding will not have the privileges of group play time. Pets that cause damages or injuries to other boarders or persons are the financial liability of their owner.

Proof of vaccinations is required. The vaccination Bordatella (kennel cough) is given at your discretion and you are solely responsible for your pet's health and understand and accept the consequences of this action including but not limited to disease and veterinarian expenses. It is advised that your pet be on a flea program.

In the unlikely event of injury or serious illness during your pet's stay, Barking Heaven reserves the right to seek veterinary care for which you, the owner will be fully responsible, including the cost of transportation to the veterinary clinic. You agree to release the kennel from any and all responsibility or liability for any claims, debts or expenses incurred for veterinary care. We will require a telephone numbers to try to reach you or your representative in the event of an emergency.

You are required to contact the kennel should you be delayed in picking up your pet on your scheduled date and time. If we do not receive any confirmation of your whereabouts within 10 days of your scheduled pick up date, we reserve the right to rehome your pet.

When you give permission for your pet to be walked and have playtime you are taking total responsibility for your pet's safety and actions.
